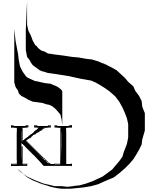

IMPORTANT NOTES:

A Registration Fee (\$50 prior to April 29th; \$100 after April 29th) payable to Keneseth Israel must be submitted with this application. This fee is non-refundable, non-transferable and is separate from tuition. Acceptance and placement of child is at the discretion of the Preschool Director.

Tuition is based on the 40 week school year beginning on September 6, 2011 and ending on June 6, 2012.

You will be billed in 9 monthly installments from September through May and are obligated to pay for the schedule indicated on this form.

If you change your child's schedule after September 1st, a tuition revision form must be submitted with a \$25 administrative fee made payable to Keneseth Israel before your child can attend. Schedule changes must be approved.

If you withdraw from the Preschool, you are responsible for payment until the end of the month following the date of departure.
